Upon completion of the account please email Vdanse, we will then complete the registration on our end. Please do not choose a specific class or contract. _____ \$50 Non-Refundable yearly registration fee per student is due On or Before JULY 15, 2019 to secure dancers registration for the upcoming season. This will be processed upon your email confirming commitment to the upcoming 2019/2020 season. ***All registration received after July 15, 2019 will have a \$25 late fee assessed- NO EXCEPTIONS.***

_____ July 28th 2019, will be the first pro-rated auto draft for 2 weeks of monthly tuition in August. Classes begin August 19th, 2019. Thereon after Full monthly tuition will be drafted on the 28th of each month for the upcoming month. Classes run through June 2020 until nationals. There is no pro-rated monthly tuition. Class time missed solely due to Holidays, breaks and Vdanse weather cancellations will be made up throughout the year TBA during additional rehearsal times. We follow school Holidays and closures.

_____ I hereby authorize VDANSE ACADEMY to enroll and teach movement/dance lessons to the student listed above. I authorize payment for services the student is enrolled in. Tuition is auto drafted ON the 28th of each month for the upcoming month. Monthly tuition is specified in start up email. Any tuition declined and received after this date will have a \$25 late fee applied. I understand there is a NO-REFUND/NO MAKE-UP policy. I understand there is a 30 day notice in writing to withdraw from classes. If there is not a 30 day notice, mindbody will continue to auto-draft payments.

_____Private sessions require **24 hr notice for cancellations** otherwise students will be charged for the session. To hold stand-in private sessions, it is required to pre-purchase a block of sessions. When a student is down to one session on the books, we require they renew their lesson block to secure future bookings. Dancers can only reserve lesson times if lessons are pre-purchased-no exceptions.
